

# **COVID-19 PANDEMIC – Current sanitary conditions**

## **MORE GENERAL RECOMMANDATIONS:**

- Avoid touching your eyes, nose or mouth
- Wash your hands regularly
- Cough or sneeze into your sleeve or a tissue, use single-use tissues and throw them away
- Do not shake hands or embrace one another
- Stay home if you are feeling unwell and see a doctor if you have fever or symptoms of illness



#### IN FRANCE:

- The EU COVID vaccination pass is mandatory to access restaurants and hotels, as well as public long distance travels (eg. Paris-Caen).
- Local public transportations are running (tram, taxi...), mask is mandatory.



## ON THE GANIL SITE:

- A quarantine period cannot be done at GANIL
- Wearing the mask is mandatory everywhere
- You are responsible to have the number of mask needed during your stay at GANIL; the lab will not provide masks for experimentalists. The masks should be of category 1 or surgical masks quality.
- The social distance must be respected: 1m with mask and 2m without mask
- Smokers should keep a distance of at least 3m.
- Hydroalcoholic gel dispensers are available in several places and should be often used
- A maximum number of persons per room has been fixed and is indicated on each accessing door.
- An experience team should not mix with another team. In the same room it is important to avoid groupings around the same workstation.
- Avoid any visit to operator room.
- GANIL's COVID contacts persons are Marie-Emilie LUCAS, Christine LAURENT and Antoine ALEMANY. The generic email address for contacting these 3 people is <a href="mailto:ref">ref</a> covid@ganil.fr</a>. The referents ensure the implementation of the measures defined in this instruction and can reply to any question on the subject. Outside working hours, contact the operators or the guards.
- A list of places where you can have a test is available at the reception desk of GANIL.



#### Meals

- The canteen is available for lunch from Monday to Friday. The number of places are limited in the dining room per time slot. You have to register for a time slot, by filling the weekly poll you receive by email.
- No breakfast can be served at the canteen during weekends and bank holidays.
- You also have the possibility to order meal trays through the portal of the catering provider on the following link <u>E-Wallet (innovorder.fr)</u>. For more details contact <u>accueil@ganil.fr</u>. For lunches and dinners, you have to order before 11 am from Monday until Friday and on Friday before 11 am for weekend meals.
- You have the possibility to have lunch in a room or office (not in restricted area, nor containing chemicals or workbenches), if you are alone or more than two meters away from another person.

## Kitchens / Guesthouse

- The kitchens in guesthouse and in the acquisition areas are open.
  - Experimentalists linked to Cimap will use the Cimap kitchen.
  - Experimentalists from rooms D3 / D4 / D5 / D6 will use the kitchen of the southern acquisitions
  - Experimentalists from rooms G1 / G2 / G3 / G4 will use the kitchen of the northern acquisitions
- The GANIL guest house will be available with half of its total capacity (i.e. 20 rooms will be available)

## Health / safety

- If you have symptoms of infection from covid19 or if you are a contact case:
  - you have to isolate yourself,
  - inform immediately laboratory's COVID referees (ref\_covid@ganil.fr)
  - undertake to perform a PCR or antigen test asap
  - inform laboratory's COVID referees (<u>ref\_covid@ganil.fr</u>) of the result of your test
- A contact case means that you have been in contact (<2m) without protective measures with a person who tested positive for COVID19 at least 15 minutes.
- Outside working hours (5.00 pm 8.30 am and week-end), if you are positive and the situation requires you to contact GANIL (e.g. guesthouse accommodation, mission, impossibility of taking up a position, etc.), please isolate yourself, inform the on-call management via the guardian by phone at 02.31.45.44.99; and wait for specific instructions that will be given to you.

Each collaborator is responsible to take care of the travelling conditions/authorization from his/her country to France and back from France (test obligations, quarantine, etc.) If you have undertaken a test or a vaccine before arriving, please carry the certificate with you (digital or paper).
